WHEREAS, this Sanggunian is in receipt of a copy of Resolution No. 2 s. 1996 embodying Ordinance No. 96-03 entitled, "AN ORDINANCE CREATING A COMPORATE SEAL OF BARANGAY CAMP DOWNES PURSUANT TO DILG ORMOC CITY MEMORANDUM CIRCULAR (S. 1996) DATED AUGUST 21, 1996";
