A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR

TARES OF LAND KNOWN AS LOT NO. 6245-A BEING A PORTION
OF LOT NO. 6245 DESCRIBED IN AND COVERED BY TRANSFER
CERTIFICATE OF TITLE NO. 12840 OF THE REGISTRY OF DEEDS
OF ORMOC CITY, SITUATED AT BARANGAY LAO, ORMOC CITY, TO
BE USED AS RELOCATION SITE FOR FAMILIES AFFECTED BY THE
FLOOD MITIGATION PROJECT OF THE CITY GOVERNMENT OF
ORMOC.

The Flood Mitigation Project of the City Government of
Ormoc necessitates the purchase of land to be used as
relocation site for the families affected by the project.

In view of this, may I respectfully request that august Body for the passage of a resolution authorizing the undersigned to purchase 7 has. of land situated at Brgy. Lao, Ormoc City for the aforementioned purpose.

Moreover, for the early implementation of the said project, this request for authority to purchase land is hereby certified URGENT.

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor Eufrocino M. Codilla, Sr. to purchase seven (7) hectares of land known as Lot No. 6245-A being a portion of Lot No. 6245 described in and covered by Transfer Certificate of Title No. 12840 of the Registry of Deeds of Ormoc City, situated at Barangay Lao, Ormoc City, to be used as relocation site for families affected by the Flood Mitigation Project of the City Government of Ormoc;

RESOLVED, FURTHER, to furnish copies of this resolution, one each, to His Honor, the City Mayor; the City Administrator, the City Legal Officer, the City Treasurer, the City Accountant, the City Engineer, the City Planning & Development Officer, the City Assessor, the Registrar - Register of Deeds, and others concerned, -all in Ormoc City;
