A RESOLUTION APPROVING THE CORRECTIONS ON THE PREVIOUSLY SUBMITTED LIST OF POSITION TITLES AND SALARY GRADES TO CONFORM WITH THE REVISED INDEX OF OCCUPATIONAL SERVICES (108), OSITION TITLES AND SALARY GRADES IN THE LOCAL GOVERNMENT (LOCAL BUNGET CIRCULAR NO. 61 S. 1996), AND IN COMPUTANCE WITH THE CIVIL SERVICE COMMISSION'S STRICT IMPLEMENTATION OF SAID CIRCULAR AFTER LECEMBER 31, 1996.

Civil Service Commission- Ormoc Field Office, this city, letter dated 21 October 1996 addressed the Honorable Mayor M. Cod 11a, Sr. pertaining to the CSCommission's request for strict implementation of Local Budget Circular No. 61 s. 1996, Revised Index of Occupational Services for Local Government Units (IOS-LGU), that "after December 31, 1996, the Commission will strictly implement said Circular of the Department of Budget & Management, hence, only appointments to positions whose titles and grades are in accord with said IOS-LGU may be favorably acted upon";
