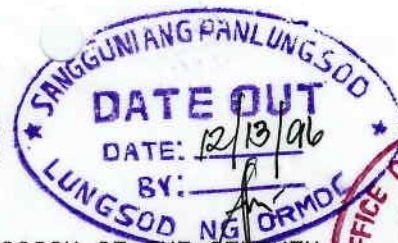

A RESOLUTION APPROVING RESOLUTION NO. 5 S. 1996 OF THE CITY DEVELOPMENT COUNCIL (CDC), THIS CITY, ENTITLED, "A RESOLUTION REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD NG ORMOC FOR APPROVAL OF THE 1997 ANNUAL INVESTMENT PLAN (AIP) OF ORMOC CITY, DULY APPROVED BY THE CITY DEVELOPMENT COUNCIL (CDC)."

WHEREAS, this Sanggunian is in receipt of sisters Resolutions Nos. 4 & 5, both series of 1996, from the City Development Council (CDC), this city, entitled:

CDC Resolution No. 4 - A RESOLUTION APPROVING THE 1997 ANNUAL INVESTMENT PROGRAM (AIP) OF ORMOC CITY.

CDC Resolution No. 5 - A RESOLUTION REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD NG ORMOC FOR APPROVAL OF THE 1997 ANNUAL INVESTMENT PLAN (AIP) OF ORMOC CITY, DULY APPROVED BY THE CITY DEVELOPMENT COUNCIL (CDC).

WHEREAS, the aforecited CDC Resolution No. 4 has stated that, as mandated by the Local Government Code, all cities and municipalities should prepare an annual list of programs and projects from out of the five (5) year local development plan wherein all the priority programs and projects are listed, hence, has made attachment, hereto attached, its approved 1997 ANNUAL INVESTMENT PLAN (AIP) OF ORMOC CITY with consideration on priorities and needs of the barangays;

WHEREAS, CDC Resolution No. 5 s. 1996 has requested the Honorable Sangguniang Panlungsod ng Ormoc for approval of CDC Resolution No. 4 s. 1996 re: the 1997 Annual Investment Plan (AIP) of Ormoc City as approved by the said Council;

WHEREFORE, foregoing premises considered, on motion of Kagawad Claudio P. Larrazabal, Chairman, Committee on Infrastructures, jointly seconded by mga Kagawad Alfredo F. Capahi and Chiqui B. Labagala; be it
