RESOLUTION NO. 96-239

A RESOLUTION APPROVING RESOLUTION NO. 8 S. 1996 OF THE CITY DEVELOPMENT COUNCIL (CDC) THIS CITY, ENTITLED, "A RESOLUTION APPROVING THE REALIGNMENT OF RECHANNELING AT BRGY. MATICA-A IN THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND PESOS, (P250,000.00), TO PILE DRIVING OF THE SAME SITE OF THE SAME AMOUNT AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD NG ORMOC FOR APPROVAL OF THE SAME."

WHEREAS, this Sanggunian is in receipt of Resolution No. 8 s. 1996 from the City Development Council, this city, entitled, "A Resolution approving the realignment of rechanneling at Brgy. Matica-a in the amount of Two Hundred Fifty Thousand Pesos (P250,000.00) to pile driving of the same site of the same amount and requesting the Honorable Sangguniang Panlungsod ng Ormoc for approval of the same";

WHEREAS, as stated in said Resolution 8, the reason for realignment "was due to the massive scouring of the river banks along Matica-a Elementary School", so that the appropriation of P250,000.00 for rechanneling be realigned to Pile driving at the same site, and, the said request is made due to the "urgency of the project for the barangay populace safety and to prevent further damages";

WHEREFORE, foregoing premises considered, on motion of Kagawad Claudio P. Larrazabal, Chairman, Committee on Infrastructures, jointly seconded by mga Kagawad Chiqui B. Labagala and Deborah Robin B. Conejos; be it

RESOLVED, to pass a resolution APPROVING RESOLUTION NO. 8 S. 1996 OF THE CITY DEVELOPMENT COUNCIL (CDC) THIS CITY, ENTITLED, "A RESOLUTION APPROVING THE REALIGNMENT OF RECHANNELING AT BRGY. MATICA-A IN THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND PESOS, (P250,000.00), TO PILE DRIVING OF THE SAME SITE OF THE SAME AMOUNT AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD NG ORMOC FOR APPROVAL OF THE SAME.";
