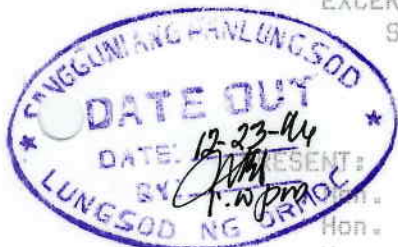

Committee on Finance, duly seconded by Kagawad Benjamin B. Lladoc; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to approve Supplemental Budget
