WHEREAS, the CDC Executive Committee has enacted on December 16, 1996 its Resolution No. 8 s. 1996, entitled, "A Resolution amending the City Development Council (CDC) Resolution No. 6 s. 1996 entitled 1997 Annual Programs and Projects from the total amount of One Hundred Eighty Four Million Six Hundred Thirty One Thousand Thirty One Pesos & 40/100 (P184,631,031.40) to One Hundred Eighty Three Million Six Hundred Thirty One Thousand Thirty One Pesos & 40/100 (P183,631,031.40) broken down as follows: a) 20% Development Project (P56,201,031.40), b) City Engineer's Office (P127,430,000.00) and requesting the Honorable Sangguniang Panlungsod ng Ormoc for approval of the same";
