RESOLUTION NO. 96-245

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR. TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE, REPRESENTED BY ITS REGIONAL DIRECTOR CIRILO R. BALAGAPO, JR., FOR IMPLEMENTATION OF THE LIVESTOCK DISPERSAL PROGRAM TO BE FUNDED FROM THE CONGRESSIONAL INITIATIVE PROGRAM OF CONGRESSMAN CARMELO LOCSIN OF THE FOURTH DISTRICT OF LEYTE IN THE AMOUNT OF TWO HUNDRED EIGHTY FIVE THOUSAND SEVEN HUNDRED FOURTEEN PESOS & 28/100 (P285,714.28).

WHEREAS, 3rd Indorsement (letter) dated 11 December 1996 of the Honorable City Mayor has requested this Sanggunian for passage of a resolution authorizing him to sign, for and in behalf of the City Government of Ormoc, a Memorandum of Agreement (MOA) to be entered into by and between the Department of Agriculture, Regional Field Office No. VIII, represented by its Regional Director Cirilo R. Balagapo, Jr. and the City Government of Ormoc;

WHEREAS, the said MOA is for the Implementation of the Livestock Dispersal Program to be funded from the Congressional Initiative Program of Congressman Carmelo Locsin, Fourth District of Leyte, amounting to P285,714.28;

WHEREAS, this august Body has considered the request of the Honorable City Mayor reasonable, hence, be accorded with due course of action;

WHEREFORE, foregoing premises considered, on motion of Kagawad Sotero M. Pepito, Chairman, Committee on Good Government & Ethics, severally seconded by mga Kagawad Benjamin B. Lladoc, Gregorio A. Yrastorza, Jr. and Claudio P. Larrazabal; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor Eufrocino M. Codilla, Sr. to sign, for and in behalf of the City Government of Ormoc, a Memorandum of Agreement with the Department of Agriculture, represented by its Regional Director Cirilo R. Balagapo, Jr., for implementation of the Livestock Dispersal Program to be funded from the Congressional Initiative Program of Congressman Carmelo Locsin of the Fourth District of Leyte in the amount of Two Hundred Eighty Five Thousand Seven Hundred Fourteen Pesos & 28/100 (P285,714.28);
