RESOLUTION NO. 96-247

A RESOLUTION APPROVING THE REQUEST OF CALIFORNIA ENERGY TO DRILL AND EXTRACT WATER AT THEIR HOUSING VILLAGE COMPOUND FOR DOMESTIC USE ONLY PROVIDED THAT THE WELL-HEAD/CASING WILL NOT EXCEED FOUR (4) INCHES IN DIAMETER AND, IN NO CASE SHALL THE WATER EXTRACTED BE USED TO PROVIDE WATER FOR A SWIMMING POOL.

WHEREAS, this august Body is in receipt of a letter dated 3 December 1996 from Mr. Marion S. Pastrano, Project Manager, California Energy, Milagro Housing Project for a Deepwell drilling for California Energy Housing Village;

WHEREAS, as a basic necessity for every community, the sustainable use of water must be properly safeguarded so that its supply will last for generations to come.

WHEREAS, along this framework the committee on Natural Resources and Environmental Control opined to approve the request of California Energy to drill and extract water for their housing village to answer to their basic needs for water;

WHEREAS, however, because of the principle of sustainability, this sanggunian recommends that this drilling should only use a well-head or casing of not more than four (4) inches in diameter and that the utilization of the extracted water will be solely for domestic use and not for a swimming pool so as to protect the supply of the surrounding barangays in particular and the aquifer of Ormoc in general;

NOW, THEREFORE, on motion of Kagawad Jose C. Alfaro, Jr., Chairman, Committee on Natural Resources and Environmental Control, duly seconded by Kagawad Claudio P. Larrazabal; be it

RESOLVED, to pass resolution APPROVING THE REQUEST OF CALIFORNIA ENERGY TO DRILL AND EXTRACT WATER AT THEIR HOUSING VILLAGE COMPOUND FOR DOMESTIC USE ONLY PROVIDED THAT THE WELL-HEAD/CASING WILL NOT EXCEED FOUR (4) INCHES IN DIAMETER AND, IS IN NO CASE SHALL THE WATER EXTRACTED BE USED TO PROVIDE WATER FOR A SWIMMING POOL;

CARRIED BY seven (7) Majority Votes with two (2) Votes against registered by Kagawad Manuel T. Fiel and Kagawad Celso P. Adolfo and three (3) abstentions registered by Kagawad Gregorio A. Yrastorza, Jr., Alfredo F. Capahi and Benjamin B. Lladoc.
