Labagala, Gregorio A. Yrastorza, Jr. and Sotero M. Pepito; be it

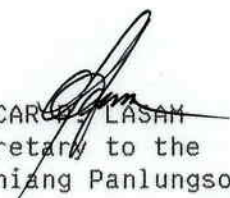
RESOLVED, AS IT IS HEREBY RESOLVED, to forego the next Regular
