A RESOLUTION APPROVING ORDINANCE NO. 01 S. 1996 OF THE BARANGAY COUNCIL OF LILO-AN, ENTITLED, "AN ORDINANCE PROHISITING THE USE OF INSECTICIDES AND OTHER POISONOUS SUBSTANCES IN THE RIVERS, IRRIGATION CANALS, AND OTHER AUBLIC WATERS, WITHIN THE JURISDICTION OF THIS BARAN-GAY, FOR THE PURPOSE OF CATCHING FISH, AND OTHER AQUAT-RESOURCES, PROVIDING PENALTIES FOR THE VIOLATION THEREOF

this Sangguniang is in receipt of Ordinance No. 01, s. from the Barangay Council of Brgy.
