RESOLUTION NO. 96-258

A RESOLUTION APPROVING ORDINANCE NO. 02 S. 1996 OF THE SANGGUNIANG BARANGAY OF BRGY. LILO-AN, THIS CITY, ENTITLES, "AN ORDINANCE PROHIBITING ASTRAY DOGS, PIGS, SOATS, CARABAOS, AND COMS ROAMING AROUND AND/OR PASTURE IN PUBLIC AND PRIVATE LANDS OTHER THAN HIS OWN, WITHIN THE JURISOICTION OF THIS BARANGAY, PROVIDING PENALTIES FOR THE VIOLATIONS THEREOF.

WHEREAS this Sanggunian is in receipt of Ordinance No. 02 s. 1996 the Sangguniang Barangay of Brgy. Lilo-an, this city, entitled, Resolution prohibiting astray dogs, pigs, goats, carabaos, and cows roaming around and/or pasture in public and private lands other than his own, within the jurisdiction of this barangay, providing penalties for the violation thereof", for review as mandated by Section 57 of the Local Government Code of 1991;

WHEREAS, upon the review made on the aforecited Ordinance of Brgy. Lilo-an, this august Body has observed that the said Ordinance has conformed to pertinent provisions of the Local Government Code, hence reasonable and within the province of said Barangay Council to legislate;

WHEREFORE, foregoing premises considered, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws & Ordinances, jointly seconded by mga Kagawad Alfredo F. Capahi and Gregorio A. Yrastorza, Jr.; be it
