BARBERS, FOR ONE (1) UNIT AERIAL LACOER, AND ONE (1) UNIT SUPER TANKER FIRETRUCK FOR THE USE OF THE GRACE CITY FIRE STATION CONSIDERING THE FAST DEVELOPMENT OF HIGH RISE BUILDINGS (UP TO 5 STOREYS) IN ORMOC CITY.
