## RESOLUTION NO. 97-05

A RESOLUTION APPROVING ORDINANCE NO. 96-005 OF THE SANGGUNIANG BARANGAY OF DONA FELIZA MEJIA, THIS CITY, ENTITLED, "AN ORDINANCE PROHIBITING ASTRAY ANIMALS, SUCH AS PIGS, GOATS, CARABAOS, COWS, HORSES, DOGS, TURKEYS AND DUCKS FROM ROAMING AROUND BARANGAY STREETS, PLAZA AND SCHOOL PREMISES, AND OTHER PUBLIC AND PRIVATE PLACES (EXCEPT OWNERS OF PRIVATE PLACES), PROVIDING PLACES (EXCEPT OW PENALTIES THEREOF."

WHEREAS, this Sanggunian is in receipt of Ordinance No. 96-005 of Sangguniang Barangay of Brgy. Doña Feliza Mejia, this city, enti-"An Ordinance prohibiting astray animals, such as pigs, goats, carabaos, cows, horses, dogs, turkeys and ducks from roaming around barangay streets, plaza and school premises, and other public and private places (except owners of private places), providing penalties thereof", for review as mandated by Section 57 of the Local Government Code of 1991;

WHEREAS, upon the review made on the aforecited Ordinance of Brgy. Doña Feliza Mejia, this august Body has observed that the said Ordinance has conformed to pertinent provisions of the Local Government Code, hence, reasonable and within the province of said Barangay Council to legislate;

WHEREFORE, foregoing premises considered, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws & Ordinances, severally seconded by mga Kagawad Chiqui B. Labagala, Benjamin B. Lladoc and Deborah Robin B. Conejos: be it
