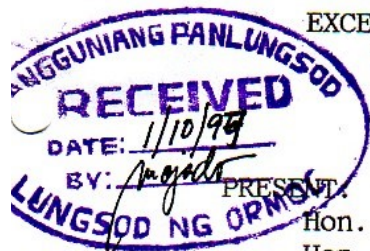
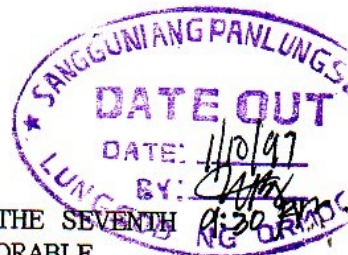

RESOLUTION NO. 97-07

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
EUFROCINO M. CODILLA, SR. TO ISSUE ADDITIONAL SEVENTY
(70) POLICE NUMBERS FOR TRICYCLES TO OPERATE WITHIN
ORMOC CITY.

WHEREAS, this august Body is in receipt of a letter from the Honorable City Mayor dated 23 December 1996 addressed the Honorable Members, 7th Sangguniang Panlungsod, thru Hon. Benjamin F. Tugonon, Vice Mayor & Presiding Officer, the full text of which is hereunder cited as follows:

Gentlemen:

As of this date, the city through the authority of the Sangguniang Panlungsod, has already granted the operations of 630 tricycle units in the city. However, due to the fast increasing number of commuters, the said figure is still found insufficient and could not meet the tricycle transportation needs of our commuters.

In view therefore of this scarcity, may I respectfully request that august Body for authority for the operations of additional 70 tricycle units in the City of Ormoc.

Anticipating your immediate favorable action on this request.
