RESOLUTION NO. 97-08

A RESOLUTION APPROVING THE PROPOSED IMPROVEMENT OF CURVA - SAN VICENTE - MAS-IN ROAD FUNDED BY THE DEPARTMENT OF AGRICULTURE FARM TO MARKET ROAD PROGRAM IN THE AMOUNT OF ONE MILLION FOUR HUNDRED THOUSAND PESOS (P1,400,000.00).

WHEREAS, this Sanggunian is in receipt of a letter dated 26 December 1996 from Engr. Ramon C. Omega, District Engineer, 2nd LED, this city, said letter has requested for approval of the Program of Work on the proposed Improvement of Curva - San Vicente - Mas-in Road funded by the Department of Agriculture Farm to Market Road Program in the amount of ONE MILLION FOUR HUNDRED THOUSAND PESOS (P1,400,000.00);

WHEREAS, of significance to state in here is City Ordinance No. 53 s. 1995 entitled, "AN ORDINANCE IMPLEMENTING THE PROVISION OF THE LOCAL GOVERNMENT CODE OF 1991 (R.A. NO. 7160) REQUIRING MANDATORY COORDINATION AND CONSULTATION WITH THE APPROPRIATE LOCAL GOVERNMENT UNITS, NON-GOVERNMENTAL AND PEOPLE'S ORGANIZATIONS AND OTHER CONCERNED SECTORS, AND APPROVAL OF SANGGUNIANG PANLUNGSOD NG ORMOC PRIOR TO THE IMPLEMENTATION OF NATIONALLY FUNDED PROJECTS/PROGRAMS, AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF", and Section 1 thereof has required "Prior Coordination, Consultation and Approval of the Sangguniang Panlungsod ng Ormoc in the Implementation of Nationally Funded Project/Program within the territorial jurisdiction of the City of Ormoc";

WHEREAS, the Honorable Members of this august Body, in Session, through the representation of the Honorable Chairman, Committee on Infrastructures, have considered the said request meritorious and reasonable, hence, must be accorded with due course of action;


Gentlemen:

This is to manifest my intention to veto Resolution No. 97-08 of that august body, - A RESOLUTION APPROVING THE PROPOSED IMPROVEMENT OF CURVA - SAN VICENTE - MAS-IN ROAD FUNDED BY THE DEPARTMENT OF AGRICULTURE FARM TO MARKET ROAD PROGRAM IN THE AMOUNT OF ONE MILLION FOUR HUNDRED THOUSAND PESOS (P1,400,000.00) in view of the following reasons, to wit:

1. The proposed road surfacing project for the improvement of Curva - San Vicente - Mas-in Road is to my mind a useless temporary remedy to assuage the poor condition of the above-mentioned road. Any improvement thereof other than concreting is just a waste of funds. Surfacing materials can easily be washed-out and eroded and no amount of surfacing work could end this endless problem not unless a concrete road will be constructed.
2. Since the thrust of the present city administration is to provide concrete roads even to far-flung barangays, it is my opinion that it is just appropriate to rather construct a concrete and permanent road than just institute an allieviatory improvement.
3. Considering the funds provided by the Department of Agriculture, I am of the idea of allocating 150 linear meters of concrete road for each of the involved barangay.

Foregoing considered, Resolution No. 97-08 is returned unsigned and it is hoped that the proposed project be amended in the interest of the public.
