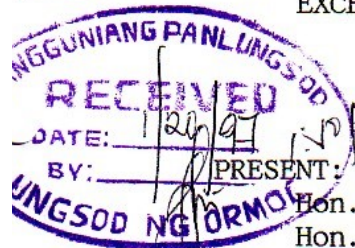
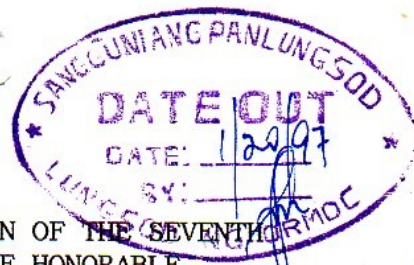

20, 1997 TO FEBRUARY 28, 1997 DUE TO THE TIGHT  
FINANCIAL SITUATION ENCOUNTERED BY THE MEMBERS OF ORMOC  
FILIPINO RETAILERS' ASSOCIATION (OFRA).

WHEREAS, this Sanggunian is in receipt of a letter dated 13 January  
1997 from the President, Ormoc Filipino Retailers' Association (OFRA)

THE MEMBERS OF ORMOC FILIPINO RETAILERS' ASSOCIATION (OFRA);


