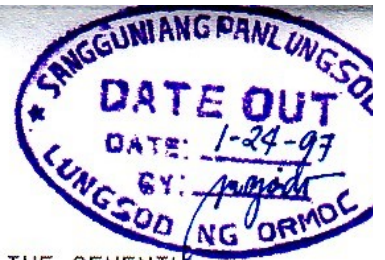

A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION OF ENGR. ERIC C. CODILLA FOR INDUSTRIAL PERMIT FOR SAND AND GRAVEL CONCESSION AT PANILAHAN RIVER PROVIDED THAT ALL THE REQUIREMENTS AND PROPER ENVIRONMENTAL PRACTICES IN THE EXTRACTION AND OPERATION ARE BEING ADHERED TO; AND PROVIDED FURTHER THAT STRICT COMPLIANCE WITH THE ENVIRONMENTAL COMPLIANCE CERTIFICATE (ECC) IS FOLLOWED.

PRESENTED to this Sanggunian for consideration is the following:

A letter from Engr. Eric C. Codilla dated 2 January 1997 addressed the Honorable Members of the 7th Sangguniang Panlungsod requesting for Sanggunian Resolution interposing no objection to his proposed application for Industrial Permit for Sand and Gravel Concession at Panilahan River, this city.

WHEREAS, the Honorable Members of the 7th Sangguniang Panlungsod, in SESSION, have considered the aforecited request of Engr. Eric C. Codilla reasonable and in order, having presented the Location Map and a Resolution (Resolution No. 15 s. 1996) of the Barangay Council of Macabug, entitled, "RESOLUTION TO GRANT THE PERMIT OF ENGR. ERIC CODILLA FOR THE EXTRACTION OF SAND AND GRAVEL SITUATED AT PAHILAHAN RIVER OF BARANGAY MACABUG, ORMOC CITY";




