A RESOLUTION RESPECTFULLY REQUESTING HONORABLE GOVERNOR YUKIO AOSHIMA THRU KANTARO SUZUKI AND PHOENIX INC., JAPAN THRU ITS PRESIDENT, TAKEAKI KAMEYAMA OR ITS PHILIPPINE AUTHORIZED SOLE REPRESENTATIVE, HIROYOSHI HIWATASHI TO DONATE USED EQUIPMENT TO THE LOCAL GOVERNMENT OF CITY OF ORMOC, LEYTE AND AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR. TO ACCEPT THE DONATION.

WHEREAS, this Sanggunian is in receipt of a letter dated 15 January 1997 from the Honorable City Mayor Eufrocino M. Codilla, Sr., addressed the Honorable Members, 7th Sangguniang Panlungsod ng Ormoc thru the Honorable Vice Mayor & Presiding Officer requesting for a Sangguniang Panlungsod Resolution for donation from Honorable Governor Yukio Aoshima thru Kantaro Suzuki and Phoenix Inc., Japan thru its President Takeaki Kameyama or its Philippine Authorized Sole representative, Hiroyoshi Hiwatashi of used equipments two (2) units Garbage Trucks with Compactor and four(4) units Dump Trucks to be used by the City Government of Ormoc in line with its Clean & Green Program and authorizing the Hon. City Mayor of Ormoc, Eufrocino M. Codilla, Sr., to accept the same;

WHEREAS, in the desire to improve the environmental upkeep of the various communities in the City of Ormoc, Leyte, the Council has embarked on comprehensive study on the waste collection and waste disposal system currently being used;

WHEREAS, the general findings include the lack of serviceable units to collect garbage and other refuse, especially in the narrow alley portion of the different barangay, which lead to slow decay and degradation to the community due to mountains of uncollected garbage;

WHEREAS, due to budgetary limitation, the City will have to look the other sources of logistic support to augment whatever for capabilities that is currently on hand;

WHEREAS, expenses incident thereto include(s) overhauling engine compactor, freight, Japan export processing and and importation paper processing (tax exemption), conversion (right to left), repainting, lettering and delivery fee. The amount allocated per unit are

NOW, THEREFORE, BE IT RESOLVED, that it is hereby respectfully requested by the Ormoc City Council to Hon. Gov. Yukio Aoshima thru Kantaro Suzuki and Phoenix Inc., Japan thru its President, Takeaki Kameyama to donate to the City of Ormoc, Leyte, 2 units of Garbage Trucks and 4 units of Dump Trucks for the purpose of servicing the narrow alleyed portion of the City for the garbage collection and mopping-up operations.

RESOLVED, FURTHER, to authorize our Hon. Mayor Eufrocino M. Codilla, Sr., to accept the DONATION from Hon. Gov. Yukio Aoshima, thru Mr. Kantaro Suzuki and Phoenix Inc., Japan and to sign any and all documents relative to said donation.
