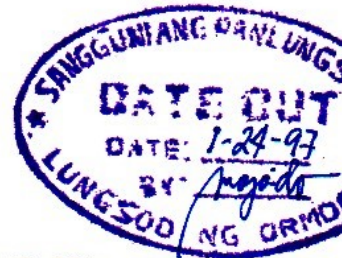

RESOLUTION NO. 97-13

A RESOLUTION APPROVING ORDINANCE NO. 96-001 OF THE SANGGUNIANG BARANGAY OF MATICA-A, THIS CITY, ENTITLED, "AN ORDINANCE IMPOSING CURFEW TO ALL PERSONS, WITHIN THE JURISDICTION OF THIS BARANGAY, FROM 10:00 O'CLOCK IN THE EVENING TO 4:00 O'CLOCK IN THE MORNING OF THE FOLLOWING DAY, FOR THE YOUTH UP TO SEVENTEEN YEARS OF AGE; AND FROM 12:00 O'CLOCK MIDNIGHT TO 4:00 O'CLOCK IN THE MORNING OF THE FOLLOWING DAY FOR PERSONS, EIGHTEEN YEARS OF AGE AND ABOVE PROVIDING PENALTIES AND EXCEPTIONS THEREOF".

WHEREAS, this Sanggunian is in receipt of Ordinance No. 96-001 of the Sangguniang Barangay of Matica-a, this city entitled, "AN ORDINANCE IMPOSING CURFEW TO ALL PERSONS, WITHIN THE JURISDICTION OF THIS BARANGAY, FROM 10:00 O'CLOCK IN THE EVENING TO 4:00 O'CLOCK IN THE MORNING OF THE FOLLOWING DAY, FOR THE YOUTH UP TO SEVENTEEN YEARS OF AGE; AND FROM 12:00 O'CLOCK MIDNIGHT TO 4:00 O'CLOCK IN THE MORNING OF THE FOLLOWING DAY FOR PERSONS, EIGHTEEN YEARS OF AGE AND ABOVE PROVIDING PENALTIES AND EXCEPTIONS THEREOF";

WHEREAS, this august Body, through the representation of the Honorable Chairman, Committee on Laws and Ordinances, has observed that said Ordinance has conformed to the pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Barangay Council of Matica-a to legislate;
