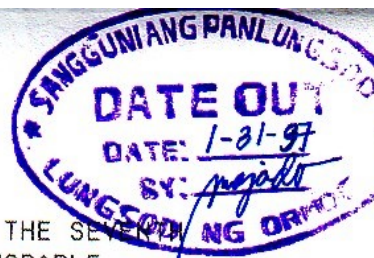

RESOLVED, to pass a resolution APPROVING THE 1997 ANNUAL BUDGETS OF THE FOLLOWING BARANGAYS:


