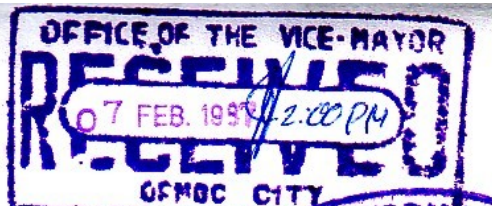

RESOLUTION NO. 97-17

A RESOLUTION APPROVING ORDINANCE NO. 96-04 OF THE SANGGUNIANG BARANGAY OF BRGY. LINAO, THIS CITY, ENTITLED, "AN ORDINANCE IMPOSING (SIC) A SANITARY FEE IN THE AMOUNT OF FIFTEEN (P15.00) PESOS PER ANNUM SHALL BE IMPOSE (SIC) ON BUSINESS ESTABLISHMENT WHOSE GROSS SALE OR RECEIPT OF THE PRECEDING CALENDAR YEAR IS P50,000.00 OR LESS, AND NOT TAXABLE BY THE CITY GOVERNMENT."

WHEREAS, this Sanggunian is in receipt of Ordinance No. 96-04 of the Sangguniang Barangay of Brgy. Linao, this city, entitled, "An Ordinance imposing (sic) a sanitary fee in the amount of fifteen (P15.00) pesos per annum shall be impose (sic) on business establishment whose gross sale or receipt of the preceding calendar year is P50,000.00 or less, and not taxable by the City Government";

WHEREAS, upon the review made on the aforecited Ordinance, this august Body has observed that said Ordinance has conformed to pertinent provisions of the Local Government Code, hence, reasonable and within the province of said Barangay Council to legislate;
