

RESOLUTION NO. 97-17

A RESOLUTION APPROVING ORDINANCE NO. 96-04 OF SANGGUNIANG BARANGAY OF BRGY. LINAO, THIS SANGGUNIANG BARANGAY OF BRGY. LINAO, THIS CITY, ENTITIED, "AN ORDINANCE EMPOSING (SIC) A SANITARY FEE IN THE AMOUNT OF FIFTEEN (\$15.00) PESOS PER ANNUM SHALL IMPOSE (SIC) ON BUSINESS ESTABLISHMENT WHOSE GROSS SALE OR RECEIPT OF THE PRECEDING CALENDAR YEAR IS P50,000.00 OR LESS, AND NOT TAXABLE BY THE CITY GOVERNMENT. "

WHEREAS, this Sanggunian is in receipt of Ordinance No. 96-04 of the Sangguniang Barangay of Brgy. Linao, this city, entitled, "An Ordinance emposing (sic) a sanitary fee in the amount of fifteen (P15.00) pesos per annum shall be impose (sic) on business establishment whose gross sale or receipt of the preceding calendar year is \$50,000.00 or less, and not taxable by the City Government";

WHEREAS, upon the review made on the aforecited Ordinance, this august Body has observed that said Ordinance has conformed to pertinent provisions of the Local Government Code, hence, reasonable and within the province of said Barangay Council to legislate;

WHEREFORE, foregoing premises considered, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws & Ordinances, severally seconded by mga Kagawad Benjamin B. Lladoc, Sotero M. Pepito and Deborah Robin B. Conejos; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to approve Ordinance No. 96-04 of the Sangguniang Barangay of Brgy. Linao, this city, entitled, "An Ordinance emposing (sic) a sanitary fee in the amount of fifteen (P15.00) per annum shall be impose (sic) on business pesos establishment whose gross sale or receipt of the preceding calendar year is \$50,000.00 or less, and not taxable by the City Government";
