RESOLUTION NO. 97-01

A RESOLUTION CERTIFYING THAT BOTH THE SANGGUNIANG
PANLUNGSOD OF ORMOC CITY AND THE SANGGUNIANG BAYAN OF
KANANGA, LEYTE HAVE FAILED TO SETTLE AMICABLY THEIR BOUNDARY
DISPUTE AND HAVE AGREED TO ELEVATE THE SAME TO THE PROPER
COURT FOR SETTLEMENT BY THE INTERESTED PARTY.

WHEREAS, on October 31, 1997 at 9:00 o'clock in the morning, both the
Sangguniang Panlungsod of Ormoc City and the Sangguniang Bayan of Kananga, Leyte
have jointly met at the Session Hall of the Sangguniang Panlungsod of Ormoc City for the
purpose of settling amicably their boundary dispute;

WHEREAS, unfortunately, however, both the Sangguniang Panlungsod of Ormoc City and the Sangguniang Bayan of Kananga, Leyte have failed to reach an amicable settlement of their boundary dispute;

WHEREAS, by reasons of holding such joint conference of both the Sangguniang Panlungsod ng Ormoc City and the Sangguniang Bayan of Kananga, Leyte and the failure of the same to arrive at an amicable settlement of their boundary dispute, the Members of the Sangguniang Panlungsod of Ormoc thru the Presiding Officer, and the Members of the Sangguniang Bayan of Kananga thru the Presiding Officer convened the Joint Session at 11:10 o'clock in the morning in order to comply with the provisions of Sec. 118 of the Local Government Code (LGC) and Art. 17 of the Rules and Regulations Implementing the Local Government Code;


WHEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties of the Sangguniang Panlungsod of Ormoc City, duly seconded by Kagawad Jose C. Alfaro of the Sangguniang Panlungsod of Ormoc City and Mayor Eduardo V. Napari of the Municipality of Kananga; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution certifying that both the Sangguniang Panlungsod of Ormoc City and the Sangguniang Bayan of Kananga, Leyte have failed to settle amicably their boundary dispute and have agreed to elevate the same to the proper court for settlement by any of the interested party.
