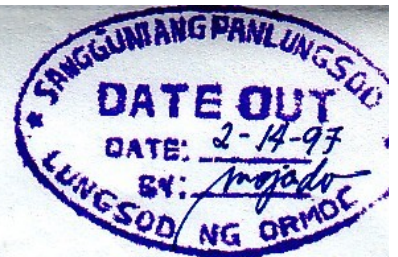

RESOLUTION NO. 97-20

A RESOLUTION APPROVING TAX ORDINANCE NO. 02 S. 1997 OF
THE SANGGUNIANG BARANGAY OF LILO-AN ENTITLED: "AN
ORDINANCE IMPOSING TAXES ON STORES OR RETAILERS,
BILLBOARDS, PRIVELEGE (SIC) PANELS, AND OTHER OUTDOOR
ADVERTISEMENTS, BARANGAY CLEARANCES AND BARANGAY PER-
MITS".

WHEREAS, this Sanggunian is in receipts of Resolution No. 97-02
embodying Barangay Tax Ordinance No. 02 of the Barangay Council of
Barangay Lilo-an, this city entitled, "AN ORDINANCE IMPOSING TAXES ON
STORES OR RETAILERS, BILLBOARDS, SIGNBOARDS, PRIVELEGE (SIC) PANELS, AND
