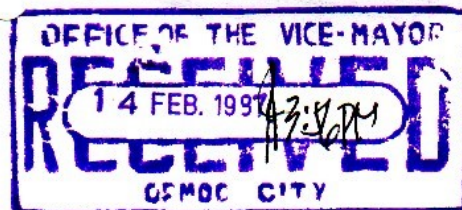

RESOLUTION NO. 97-23

A RESOLUTION APPROVING CDC RESOLUTION NO. 1 SERIES OF 1997, ENTITLED: "A RESOLUTION AMENDING CDC RESOLUTION NO. 12 SERIES OF 1990 ENTITLED, "A RESOLUTION APPROVING THE PROPOSED PROVINCIAL INDUSTRIAL CENTER SITE AT BARANGAY MACABUG, ORMOC CITY" BY TRANSFERRING IT TO BARANGAYS LUNA, DAYHAGAN, AND DOLORES, AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD NG ORMOC FOR APPROVAL OF THE SAME."

WHEREAS, the 5th Sangguniang Panlungsod ng Ormoc has passed Resolution No. 76 s. 1990 identifying certain portions of Barangay Macabug, this city, as Provincial Industrial Center (PIC) site;

WHEREAS, however, as stated in the Recommendation Report prepared by the Zoning Officer III, said area is no longer viable for said project considering that said area was submerged underwater during the Ormoc Flash Flood on November 5, 1991;

WHEREAS, in lieu of Barangay Macabug, the CDC has identified Barangays Luna, Dayhagan, and Dolores as alternate sites of the proposed Provincial Industrial Center (PIC) and has considered said areas as ideal site;

WHEREFORE, foregoing premises considered, on motion of Kagawad Manuel T. Fiel, Chairman, Committee on Zoning and Beautification jointly seconded by mga Kagawad Alfredo F. Capahi and Chiqui B. Labagala; be it

RESOLVED, to pass a resolution APPROVING CDC RESOLUTION NO. 1 SERIES OF 1997, ENTITLED: "A RESOLUTION AMENDING CDC RESOLUTION NO. 12 SERIES OF 1990 ENTITLED, "A RESOLUTION APPROVING THE PROPOSED PROVINCIAL INDUSTRIAL CENTER SITE AT BARANGAY MACABUG, ORMOC CITY" BY TRANSFERRING IT TO BARANGAYS LUNA, DAYHAGAN, AND DOLORES, AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD NG ORMOC FOR APPROVAL OF THE SAME";
