RESOLUTION NO. 97-24

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY
MAYOR EUFROCINO M. CODILLA, SR. TO SIGN, FOR AND IN
BEHALF OF THE CITY GOVERNMENT OF ORMOC, AS DONOR, A
DEED OF DONATION IN FAVOR OF THE DEPARTMENT OF JUSTICE,
INVOLVING A PARCEL OF LAND KNOWN AS PROPOSED RTC BRANCH
35 SITUATED IN THE POBLACION OF ORMOC CITY, COVERING AN
AREA OF FOUR HUNDRED NINETEEN (419) SQUARE METERS, MORE
OR LESS, PROVIDED THAT THE DONOR HEREBY RETAINS THE
RIGHT OF OWNERSHIP OR THE PROPERTY REVERTS BACK IN CASE
THE DONEE WILL CEASE TO USE THE LAND DONATED BY THE
CITY GOVERNMENT.
