

RESOLUTION NO. 97-29

A RESOLUTION APPROVING BARANGAY TAX ORDINANCE NO. 01 SERIES OF 1997 OF THE SANGGUNIANG BARANGAY OF CONCEPCION, ORMOC CITY, ENTITLED: "AN ORDINANCE IMPOSING TAXES ON STORES OR RETAILERS, SIGN, SIGNBOARD, BILLBOARD, PRIVELEGE PANELS, OTHER OUTDOOR ADVERTISEMENTS, BARANGAY CLEARANCE, AND BARANGAY PERMITS".

WHEREAS, this Sanggunian is in receipt of Resolution No. 57 s. 1997 embodying Tax Ordinance No. 01 s. 1997 of the Barangay Council of Concepcion, this city entitled: "AN ORDINANCE IMPOSING TAXES ON STORES OR RETAILERS, SIGN, SIGNBOARD, BILLBOARD, PRIVELEGE PANELS, OTHER OUTDOOR ADVERTISEMENTS, BARANGAY CLEARANCE AND BARANGAY PERMITS", for review as mandated by Section 57 of the Local Government Code of 1991;
