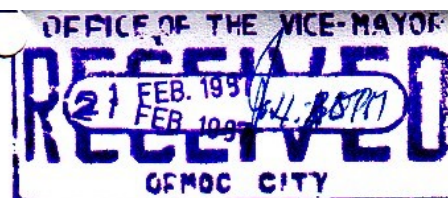

SUBSTATION (PTS), TO SUSPEND OR ADVISE THE PEOPLE IN-
VOLVED TO GO ON AN INDEFINITE LEAVE OF ABSENCE DURING
THE PENDENCY OF THE CASE AND FOR THE NEA TO TAKE OVER
THE MANAGEMENT OF LEYECO V UNTIL THE CASE IS RESOLVED.
