

## RESOLUTION NO. 97-34

A RESOLUTION APPROVING TAX ORDINANCE NO. 01 S. 1997 OF SANGGUNIANG BARANGAY OF BRGY. R.M. TAN ENTITLED, 'AN ORDINANCE CHARGING A FEE ON THE USE OF THE BARANGAY BASKETBALL COURTS OR OF ANY PORTION OF THE MULTI-PURPOSE PAVEMENTS FOR DRYING MATERIALS.

WHEREAS, this Sanggunian is in receipt of Ordinance No. 01 s. 1997 of the Sangguniang Barangay of Brgy. R.M. Tan, this city, entitled, Ordinance charging a fee on the use of the barangay basketball courts or of any portion of the barangay multi-purpose pavements for drying grains and similar materials", for review action as mandated by Section 57 of the Local Government Code of 1991;

WHEREAS, upon the review made on the aforecited Ordinance of Brgy. Tan, this august Body has observed that the said Ordinance has conformed to pertinent provisions of the Local Government Code, hence, reasonable and within the province of said Barangay Council legislate;
