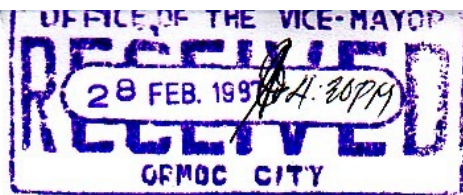

RESOLUTION NO. 97-36

A RESOLUTION APPROVING ORDINANCE NO. 97-01 SERIES OF 1997 OF THE SANGGUNIANG BARANGAY OF LINAO ENTITLED: "AN ORDINANCE IMPOSING PENALTIES TO OWNERS OF VEHICLES AND ASTRAY ANIMALS AND PERSON THAT CAUSE DAMAGE TO ORNAMENTAL PLANTS, TRASH RECEPTACLES, FENCES AND OTHER CLEAN AND GREEN DEVICES WITHIN THE JURISDICTION OF BARANGAY LINAO, ORMOC CITY".

WHEREAS, this Sanggunian is in receipt of Ordinance No. 97-01 series of 1997 of the Sangguniang Barangay of Barangay Linao, this city, entitled, "AN ORDINANCE IMPOSING PENALTIES TO OWNERS OF VEHICLES AND ASTRAY ANIMALS AND PERSON THAT CAUSE DAMAGE TO ORNAMENTAL PLANTS, TRASH RECEPTACLES, FENCES AND OTHER CLEAN AND GREEN DEVICES WITHIN THE JURISDICTION OF BARANGAY LINAO, ORMOC CITY";
