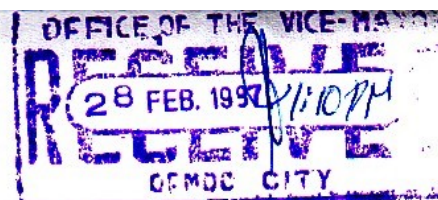
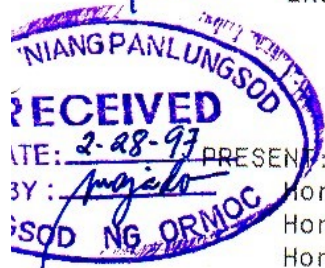

RESOLUTION NO. 97-37

A RESOLUTION EXTENDING THE DEADLINE OF PAYMENT OF CITY  
LICENSES/MAYOR'S PERMITS FROM FEBRUARY 28 TO MARCH 31,  
1997.

WHEREAS, this Sanggunian has passed Resolution No. 97-10 dated 16 January 1997 entitled, "A RESOLUTION EXTENDING THE DEADLINE FOR RENEWAL OF THE CITY LICENSES/MAYOR'S PERMIT OF BUSINESS FROM JANUARY 20, 1997 TO FEBRUARY 28, 1997 DUE TO THE TIGHT FINANCIAL SITUATION ENCOUNTERED BY THE MEMBERS OF ORMOC FILIPINO RETAILERS' ASSOCIATION (OFRA)";

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 24 February 1997 from the Office of the City Mayor, with attachment of a letter dated 21 February 1997 from the Ormoc Filipino Retailers' Association (OFRA) requesting for another extension of the deadline for renewal of city permits/ mayor's licenses from February 28 to March 31, 1997, for majority of the members/taxpayers "have not yet fully complied with the requisites for the issuance of city licenses/mayor's permits especially the additional requirements- the BIR tax clearance, SSS clearance, etcetera";

WHEREAS, in view of the aforementioned reasons, this august Body has considered reasonable to temporarily suspend the operation of Section 1.2.1.4 of Tax Ordinance No. 1 s. 1974, otherwise known as the "Ormoc City Revenue Code of 1977" fixing the first twenty (20) days of January to pay the obligations to the government, to provide not only the members of the aforementioned retailers association, but also all taxpayers with ample time to meet the various requirements regarding tax obligations;

WHEREAS, foregoing premises considered, on motion of Kagawad Alfredo F. Capahi, Chairman, Committee on Finance, severally seconded by mga Kagawad Manuel T. Fiel, Deborah Robin B. Conejos, Benjamin B. Lladoc and Celso P. Adolfo; be it

RESOLVED, to pass a resolution EXTENDING THE DEADLINE OF PAYMENT OF CITY LICENSES/MAYOR'S PERMITS FROM FEBRUARY 28 TO MARCH 31, 1997;

ENACTED, February 27, 1997.

RESOLVED, FURTHER, to furnish copies of this resolution each to His Honor, the City Mayor; the City Administrator, the City Treasurer, the City Accountant, the City Auditor and the President- Ormoc Filipino Retailers Association (OFRA), -all in Ormoc City;
