A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR. TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT, WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, REPRESENTED BY ITS REGIONAL DIRECTOR AIDA P. DOMINGO.
