RESOLUTION NO. 97-41

A RESOLUTION REQUESTING CITY LEGAL OFFICER, ATTY. CLETO L. EVANGELISTA, JR., TO FOLLOW UP THE PENDING BOUNDARY DISPUTE RETWEEN THE CITY OF ORMOC AND THE MUNICIPALITY KANANGA, LEYTE, AT THE OFFICE OF THE LANDS MANAGE-SERVICE, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), REGION 08, TACLOBAN CITY, AND FURTHER REQUESTING HIM TO SUBMIT HIS REPORT THEREON TO THIS SANGGUNIAN.

HEREAS, the boundary dispute between the City of Ormoc and Municipality of Kananga, Leyte, is still pending resolution by the Office of the Lands Management Service, Department of Environment and Natural Resources, notwithstanding the submission of the Manifestation by the Municipality of Kananga in the later part of December, 1995, and the Counter-Memorandum of the City of Ormoc in the later part of February, 1996;

WHEREAS, this Sanggunian on August 15, 1996, passed Resolution No. 96-128, entitled: "A RESOLUTION RESPECTFULLY URGING THE REGIONAL TECH-NICAL DIRECTOR, LANDS MANAGEMENT SERVICE, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, REGION 08, TACLOBAN CITY, TO RESOLVE WITH DISPATCH THE PENDING BOUNDARY DISPUTE BETWEEN THE CITY OF ORMOC AND THE MUNICI-PALITY OF KANANGA, LEYTE";

WHEREAS, notwithstanding the foregoing premises, the Regional Technical Director, Lands Management Service, Department of Environment and Natural Resources, Region 08, Tacloban City, has, up to the present, failed to resolve the said controversy;

WHEREAS, it is now the sense of this Sanggunian that a personal follow-up is needed, if only to know the present status of the said controversy, and the cause or causes, the reason or reasons why until now the Regional Technical Director, Lands Management Service, DENR, Tacloban City, has not come out with the resolution of this case;

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution requesting City Legal Officer, Atty. Cleto L. Evangelista, Jr., to follow up the pending boundary dispute between the City of Ormoc and the Municipality of Kananga, Leyte, at the Office of the Lands Management Service, Department of Environment and Natural Resources, Region 08, and further requesting him to submit his report thereon to this Sanggunian;
