RESOLUTION NO. 97-42

A RESOLUTION APPROVING ORDINANCE NO. 02 S. 1997 OF THE SANGGUNIANG BARANGAY OF BRGY. DONGHOL, THIS CITY, ENTITLED, "AN ORDINANCE PROHIBITING THE USE OF INSECTICIDES AND OTHER POISONOUS SUBSTANCES IN RIVERS, BROOK, LAKE, CANALS WITHIN THE JURISDICTION OF BARANGAY DONGHOL, FOR THE PURPOSE OF CATCHING FISHES AND OTHER AQUATIC RESOURCES."

WHEREAS, this Sanggunian is in receipt of Ordinance No. 02 s. 1997 of the Sanggunian Barangay of Brgy. Donghol, this city, entitled, "An Ordinance prohibiting the use of insecticides and other poisonous substances in rivers, brook, lake, canals within the jurisdiction of Barangay Donghol, for the purpose of catching fishes and other aquatic resources", for review action as mandated by Section 57 of the Local Government Code of 1991;

WHEREAS, upon the review made on the aforecited Ordinance of Brgy. Donghol, this august Body has observed that the said Ordinance has conformed to pertinent provisions of the Local Government Code, hence, reasonable and within the province of said Barangay Council to legislate;
