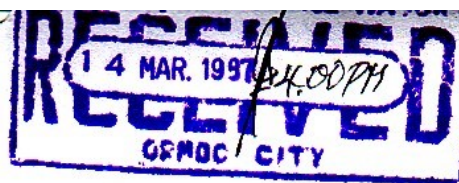
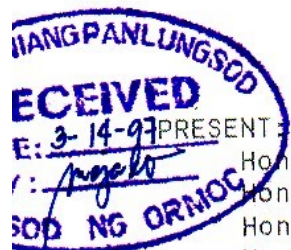

RESOLUTION NO. 97-43

A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION FOR COMPLEX SUBDIVISION PROJECT AMONG CO-HEIRS RUFINO Y. CON-UI ET AL COMPRISING LOT NO. 11772, ORMOC CADASTRE AND LOT NO. 1171-8-2-H-9, PSD-08-000699 LOCATED AT BARANGAY COGON, ORMOC CITY, WITH A PROJECT AREA OF 86,139 SQ. M., MORE OR LESS, COVERED BY TRANSFER CERTIFICATES OF TITLE NOS. 24840 AND 24842 CONTAINING TWENTY FIVE (25) SUBDIVISION LOTS EXCLUDING ROAD LOTS.

PRESENTED for consideration by this august Body is the following:

An application for complex subdivision project among co-heirs Rufino Y. Con-ui, et. al. comprising Lot No. 11772, Ormoc Cadastre and Lot No. 11771-B-2-H-9, Psd-08-000699 located at Brgy. Cogon, this city, with project area of 86,139 sq. meters covered by TCT Nos. 24840 and 24842 containing 25 subdivision lots excluding road lots.

WHEREAS, this august Body has found out that the site of said proposed subdivision project was duly inspected as it is "Within commercial use as per Urban Land Use of Ormoc City. X X X, however, per letter of Atty. Gonzalo CH. Tumalak, Regional Officer, HLRB Region VIII, dated January 3, 1997, subdivision among co-heirs is an exempt transaction (Underscoring Supplied) X X X. The road width is not that prescribed as minimum under the PD 957 law so long as the co-heirs agreed among themselves as to the minimal easement";

WHEREFORE, foregoing premises considered, on motion of Kagawad Manuel T. Fiel, Chairman, Committee on Zoning and Beautification, duly seconded by Kagawad Benjamin B. Lladoc; be it
