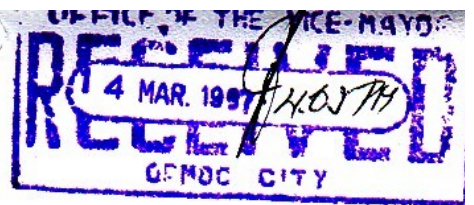
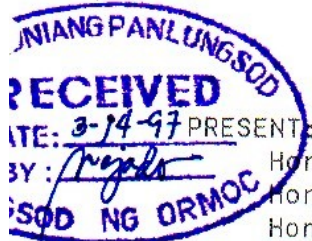

RESOLUTION NO. 97-45

A RESOLUTION APPROVING ORDINANCE NO. 97-002 SERIES OF 1997 OF THE SANGGUNIANG BARANGAY OF R.M. TAN ENTITLED: "AN ORDINANCE PRESCRIBING THE RATES ON THE USE OF WATER RESOURCE FROM THE BARANGAY WATER SYSTEM FOR DOMESTIC USE."
