A RESOLUTION INQUIRING FROM THE ADMINISTRATOR, NATIONAL ELECTRIFICATION ADMINISTRATION (NEA), QUEZON CITY, AS TO THE ACTION TAKEN ON THE REPORT AND RECOMMENDATIONS OF THE NEA INVESTIGATION TEAM WHICH CONDUCTED AN AUDIT INVESTIGATION OF THE 10 MVA POWER TRANSFORMER SUBSTATION (PTS) PURCHASED BY LEYECO V FROM PEAM.
