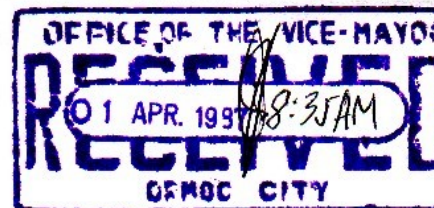

Benjamin B. Lladoc; be it

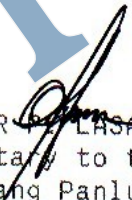

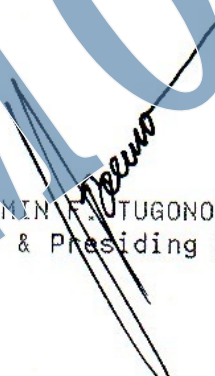
