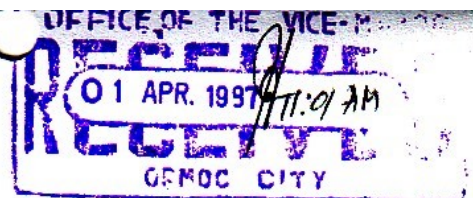

Gentlemen:

Sometime on August 1996 at Pongos Hotel Parking Area, this city, a Mitsubishi Lancer GLI Four Door Sedan, Model 1995, colored white, bearing Plate No. 4G15A-B0946 was recovered by the Ormoc City Police Office, Camp Downes, Ormoc City.

The said motor vehicle has been in the custody of TMC, PRO8 for a period of eight (8) months now and despite verification efforts made by the Traffic Office in Camp Crame, Metro-Manila, owner/claimant of the same could not be located nor pinpointed.

Inasmuch as per policy, guidelines and rules and regulations of the Traffic Management Office pertaining to abandoned motor vehicles, six (6) months from recovery the said motor vehicle could be sold to public auction thru proper biddings, may I request the honorable members of this body for the passage of a resolution requesting the Honorable Robert Z.
