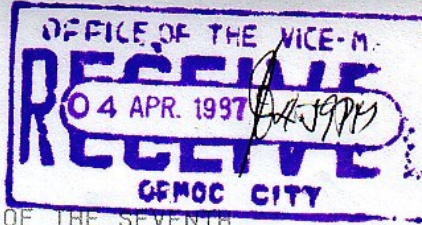

RESOLUTION NO. 97-52

A RESOLUTION APPROVING BARANGAY TAX ORDINANCE NO. 97-001  
S. 1997 OF THE SANGGUNIAN BARANGAY OF BARANGAY LIBERTY,  
THIS CITY, ENTITLED: "AN ORDINANCE IMPOSING TAXES ON  
STORES OR RETAILERS, BILLBOARDS, SIGNBOARDS, PRIVILEGE  
PANELS, AND OTHER OUTDOOR ADVERTISEMENTS, BARANGAY  
CLEARANCES, AND BARANGAY PERMITS."

WHEREAS, this Sanggunian is in receipt of Resolution No. 97-00 from  
the Barangay Council of Barangay Liberty, this city, embodying Barangay  
Tax Ordinance No. 97-001 entitled: "AN ORDINANCE IMPOSING TAXES ON  
STORES OR RETAILERS, BILLBOARDS, SIGNBOARDS, PRIVILEGE PANELS, AND OTHER


