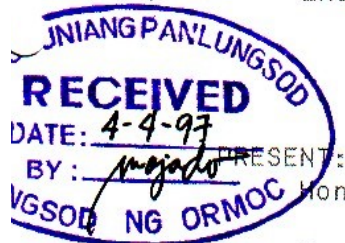

RESOLUTION NO. 97-53

A RESOLUTION APPROVING BARANGAY TAX ORDINANCE NO. 97-01  
S. 1997 OF THE SANGGUNIANG BARANGAY OF BRGY. LAO, ORMOC  
CITY, ENTITLED, "AN ORDINANCE IMPOSING TAXES ON STORES  
OR RETAILERS, BILLBOARDS, SIGNBOARDS, PRIVILEGE PANELS,  
AND OTHER OUTDOOR ADVERTISEMENTS AND TO ISSUE BARANGAY  
CLEARANCES AND BARANGAY PERMITS."

WHEREAS, this Sanggunian is in receipt of Barangay Tax Ordinance  
No. 97-01 s. 1997 from the Sangguniang Barangay of Brgy. Lao, this city,  
entitled, "An Ordinance imposing taxes on stores or retailers, bill-  
boards, signboards, privilege panels, and other outdoor advertisements  
and to issue Barangay Clearances and Barangay Permits", for review  
action as mandated by Section 57 of the Local Government Code of 1991;

WHEREAS, upon the review made on the aforecited Ordinance of Baran-  
gay Lao, this august Body has observed that the said Ordinance has  
conformed to pertinent provisions of the Local Government Code, hence,  
reasonable and within the province of said Barangay Council to legis-  
late;
