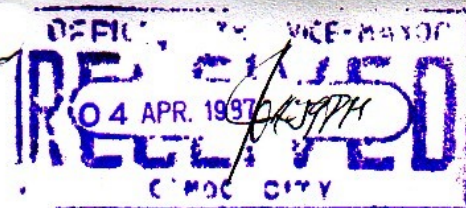
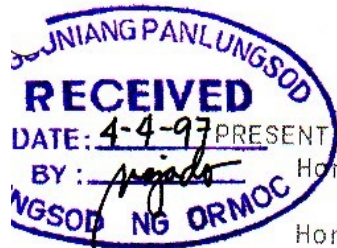

RESOLUTION NO. 97-54

A RESOLUTION SEEKING FROM THE NATIONAL HISTORICAL COMMISSION AN ADVICE ON THE PROPRIETY OF CHANGING THE NAME OF BARANGAY KADAOHAN, THIS CITY, TO BARANGAY BONIFACIO NAVARRO AS REQUESTED BY THE BARANGAY OFFICIALS OF BARANGAY KADAOHAN AS EMBODIED IN THEIR RESOLUTION NO. 22, SERIES OF 1997, COPY OF WHICH IS HERETO ATTACHED FOR READY REFERENCE.

WHEREAS, this august Body is in receipt of Resolution No. 21, Series of 1997, of Barangay Kadaohan, entitled: "A RESOLUTION EARNESTLY RECOMMENDING TO THE AUGUST MEMBERS OF THE SEVENTH SANGGUNIANG PANLUNGSOD NG ORMOC TO RENAME BARANGAY KADAOHAN, ORMOC CITY, TO BARANGAY BONIFACIO NAVARRO, ORMOC CITY, AS A TRIBUTE TO THE MAN WHO PLAYED A KEY ROLE IN THE CREATION OF THE BARANGAY";

WHEREAS, Section 13, paragraph (b) of Republic Act 7160, otherwise known as the Local Government Code of 1991, in part provides:

"(b) The sanggunians of highly urbanized cities and of component cities whose charters prohibit their voters from voting for provincial elective officials, hereinafter referred to in this Code as independent component cities, may, in CONSULTATION WITH THE PHILIPPINE HISTORICAL COMMISSION, change the name of the following within its territorial jurisdiction:



- (1) CITY BARANGAYS, UPON THE RECOMMENDATION OF THE SANGGUNIANG BARANGAY CONCERNED"; (Emphasis supplied).

WHEREAS, Ormoc City is classified as an independent component city, as the voters hereof are prohibited by its charter from voting for provincial elective officials;

WHEREAS, the present name of Barangay Kadaohan has no historical, cultural, ethnic significance, as the name "KADAOHAN" merely means a cluster of trees known, as "DAO";

WHEREAS, the reason for the renaming of the barangay is contained in aforementioned Resolution No. 21, Series of 1997, of Barangay Kadaohan;

WHEREAS, it is the sense of this august Body that the will and desire of the people of the barangay should be respected, hence, this Sanggunian interposes no objection to the renaming of Barangay Kadaohan to Barangay Bonifacio Navarro, provided that the required RATIFICATION in a plebiscite called for the purpose be held to comply with the requirements of Article 23, paragraph (b) of the Rules and Regulations Implementing the Local Government Code of 1991;

WHEREFORE, on motion presented by Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, severally seconded by mga Kagawad Alfredo F. Capahi, Gregorio A. Yrastorza, Jr., Sotero M. Pepito, Benjamin B. Lladoc & Deborah Robin B. Conejos; be it,

RESOLVED, to pass a resolution SEEKING FROM THE NATIONAL HISTORICAL COMMISSION AN ADVICE ON THE PROPRIETY OF CHANGING THE NAME OF BARANGAY KADAOHAN, THIS CITY, TO BARANGAY BONIFACIO NAVARRO AS REQUESTED BY THE BARANGAY OFFICIALS OF BARANGAY KADAOHAN AS EMBODIED IN THEIR RESOLUTION NO. 22, SERIES OF 1997, COPY OF WHICH IS HERETO ATTACHED FOR READY REFERENCE;

RESOLVED, FURTHER, to furnish copies of this resolution, one each, to the Honorable Commissioner, National Historical Commission, Metro Manila; the Hon. City Mayor of Ormoc, Hon. Eufrocino M. Codilla, Sr.; the Punong Barangay of Brgy. Kadaohan, Ormoc City; DILG, Ormoc City, and all other Offices concerned in Ormoc City;
