


RESOLUTION NO. 97-55

A RESOLUTION STRONGLY AND FAVORABLY ENDORSING TO HIS EXCELLENCY, PRESIDENT FIDEL V. RAMOS, THE WITHIN RESOLUTION NO. 6, SERIES OF 1997, OF THE SANGGUNIANG BARANGAY OF BRGY. CAMP DOWNES, THIS CITY, ENTITLED, "A RESOLUTION EARNESTLY REQUESTING THE CITY MAYOR, HON. EUFROCINO M. CODILLA, SR., THRU THE SANGGUNIANG PANLUNGSOD NG ORMOC, TO ENDORSE THE ATTACHED PETITION OF THE BARANGAY CAMP DOWNES RESIDENTS' ASSOCIATION MOST RESPECTFULLY REQUESTING HIS EXCELLENCY, PRESIDENT FIDEL V. RAMOS, TO SEGREGATE AND RECLASSIFY A PORTION OF CAMP DOWNES MILITARY RESERVATION, SPECIFICALLY NINE (9) HECTARES THEREOF, INTO A RESIDENTIAL AREA SO AS TO ESTABLISH SEPARATE TERRITORY FOR BARANGAY CAMP DOWNES AND LOTS THEREIN TO BE AWARDED TO ACTUAL RESIDENTS."

WHEREAS, this Sanggunian is in receipt of Resolution No. 6 s. 1997 from the Sangguniang Barangay of Brgy. Camp Downes, Ormoc City, entitled, "A Resolution earnestly requesting the City Mayor, Honorable Eufrocino M. Codilla, Sr., thru the Sangguniang Panlungsod ng Ormoc, to endorse the attached petition of the Barangay Camp Downes Residents' Association most respectfully requesting His Excellency, President Fidel V. Ramos, to segregate and reclassify a portion of Camp Downes Military Reservation, specifically nine (9) hectares thereof, into a residential area so as to establish separate territory for Barangay Camp Downes and lots therein to be awarded to actual residents";

WHEREAS, the Honorable Members of the 7th Sangguniang Panlungsod ng Ormoc, in Session, have considered the aforementioned barangay resolution valid, justiciable and meritorious, hence, be accorded with due course of action;

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws & Ordinances, severally seconded by mga Kagawad Sotero M. Pepito, Benjamin B. Lladoc and Deborah Robin B. Conejos; be it

CAMP DOWNES, THIS CITY, ENTITLED, "A RESOLUTION EARNESTLY REQUESTING THE CITY MAYOR, HON. EUFROCINO M. CODILLA, SR., THRU THE SANGGUNIANG PANLUNGSOD NG ORMOC, TO ENDORSE THE ATTACHED PETITION OF THE BARANGAY CAMP DOWNES RESIDENTS' ASSOCIATION MOST RESPECTFULLY REQUESTING HIS EXCELLENCY, PRESIDENT FIDEL V.
