RESOLUTION NO. 97-56

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, THE DEED OF DONATION IN FAVOR OF THE PHILIPPINE COAST GUARD, AS THE SITE OF THE PROPOSED ORMOC CITY LIGHT HOUSE, PROVIDED, THAT THE LOT DONATED WILL BE USED FOR THE INTENDED PURPOSE, OTHERWISE, THE DONATION BECOMES INEFFECTIVE.

WHEREAS, this Sanggunian is in receipt of a letter from the Honorable City Mayor of Ormoc Eufrocino M. Codilla, Sr., dated 14 March 1997 addressed the HONORABLE MEMBERS, 7th Sangguniang Panlungsod, this city, thru the Honorable Vice Mayor and Presiding Officer, the full text of which is hereunder cited as follows:

WHEREAS, based on the Technical Description prepared by Engr. Darlito A. Pareja, Tax Mapper IV, said lot is known as:

(Proposed Ormoc City Light House). Situated in the Poblacion, City of Ormoc, Island of Leyte. Bounded on the N.E., along line 2-3 by Basketball Court; on the S.E., and S.W., along line 3-4 and 4-1 by 4.00 m. road, on the N.W., along line 1-2 by Skating Rink. Beginning at a point marked "1" on the plan being S. 18 deg. 39'E., 347-35 m. from B.L.L.M. No. 1, Ormoc Cadastre;

thence N. 37 deg. 01'E.,	5.20 m. to point 2;
thence S. 44 deg. 08'E.,	12.19 m. to point 3;
thence S. 33 deg. 45'W.,	3.04 m. to point 4;
thence N. 54 deg. 19'W.,	12.22 m. to point of

the beginning, containing an area of FIFTY (50) Square Meter more or less, bearing true.

CODILLA, SR., TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, THE DEED OF DONATION IN FAVOR OF THE PHILIPPINE COAST GUARD, AS THE SITE OF THE PROPOSED ORMOC CITY LIGHT HOUSE, PROVIDED, THAT THE LOT DONATED WILL BE USED FOR THE INTENDED PURPOSE, OTHERWISE, THE DONATION BECOMES INEFFECTIVE;


