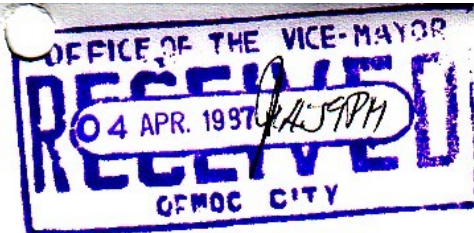

A RESOLUTION APPROVING THE APPLICATION FOR COMPLEX
SUBDIVISION PROJECT FOR LOT NO. 3050-A, PSD-08-008735-D
OWNED BY MR. CIRIACO P. AVILES LOCATED AT BARANGAY SAN
PABLO, ORMOC CITY, WITH A TOTAL PROJECT AREA OF 3,907
SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE
NO. 29605 CONTAINING FIVE (5) SUBDIVISION LOTS
EXCLUDING ROAD LOTS.
