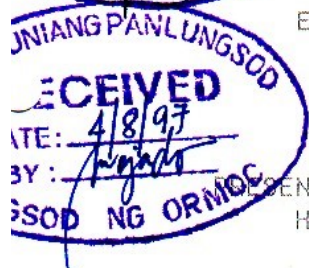
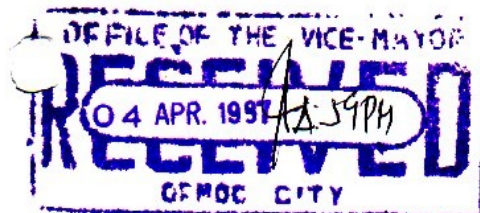

RESOLUTION NO. 97-58

A RESOLUTION REQUESTING THE COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICE (CENRO), ALBUERA, LEYTE, TO RESERVE LOT NOS. 3525 AND 3528, SITUATED AT BARANGAY MACABUG, ORMOC CITY, TO BE USED AS GARBAGE DUMPSITE FOR THE CITY GOVERNMENT OF ORMOC.

WHEREAS, this Sanggunian is in receipt of 3rd Indorsement dated 24 March 1997 from the Honorable City Mayor Eufrocino M. Codilla, Sr., requesting for the passage of a resolution reserving Lot No. 3525 and 3528 situated in Barangay Macabug, this city, to be used as Garbage Dumpsite for the City of Ormoc;
