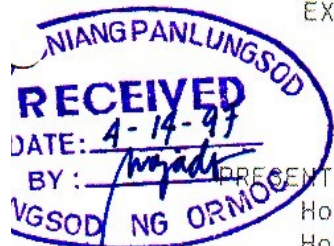
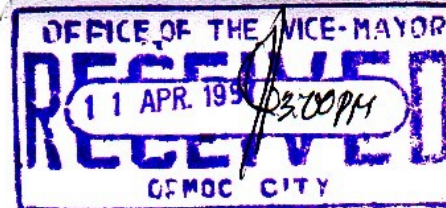

RESOLUTION NO. 97-60

A RESOLUTION APPROVING THE PROGRAMS OF WORK AND DETAILED
ESTIMATES FOR THE CONSTRUCTION OF THE FOLLOWING PRO-
JECTS:

1. CONSTRUCTION OF BARANGAY MINI PARK, BARANGAY IPIL, ORMOC CITY.
2. CONSTRUCTION OF CHILDREN'S PARK, FATIMA, COGON, ORMOC CITY.

WHEREAS, this Sanggunian is in receipt of a letter dated 17 March 1997 from Engr. Ramon C. Omega, District Engineer, 2nd LED, this city, for approval of the Programs of Work and Detailed Estimates of the following:

1. Construction of Children's Park, Fatima, Cogon, Ormoc City.
2. Construction of Barangay Mini Park, Barangay Ipil, Ormoc City.

WHEREAS, of significance to state in here is City Ordinance No. 53 s. 1995 entitled "AN ORDINANCE IMPLEMENTING THE PROVISION OF THE LOCAL GOVERNMENT CODE OF 1991 (R.A. 7160) REQUIRING MANDATORY COORDINATION AND CONSULTATION WITH THE APPROPRIATE LOCAL GOVERNMENT UNITS, NON-GOVERNMENTAL AND PEOPLE'S ORGANIZATION AND OTHER CONCERNED SECTORS, AND APPROVAL OF THE SANGGUNIANG PANLUNGSOD NG ORMOC PRIOR TO THE IMPLEMENTATION OF NATIONALLY FUNDED PROJECTS/PROGRAMS, AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF," and Section 1 thereof has required "Prior Coordination, Consultation and Approval of the Sangguniang Panlungsod ng Ormoc in the Implementation of Nationally Funded Project/Program within the territorial jurisdiction of the City of Ormoc";

WHEREAS, the Honorable City Mayor through 3rd Indorsement dated 1 April 1997 has stated that "the undersigned interposes no objection to the construction of the aforementioned projects";

WHEREAS, this august Body, through the representation of the Honorable Chairman, Committee on Infrastructures, has considered the aforementioned request of the District Engineer, 2nd LED, this city, as meritorious and reasonable hence, must be accorded with due course of action;

WHEREFORE, premises considered, on motion of Kagawad Claudio P. Larrazabal, Chairman, Committee on Infrastructures, duly seconded by Kagawad Sotero M. Pepito; be it

RESOLVED, to pass a resolution APPROVING THE PROGRAMS OF WORK AND DETAILED ESTIMATES FOR THE CONSTRUCTION OF THE FOLLOWING PROJECTS:

1. CONSTRUCTION OF BARANGAY MINI PARK, BARANGAY IPIL, ORMOC CITY.
2. CONSTRUCTION OF CHILDREN'S PARK, FATIMA, COGON, ORMOC CITY.
