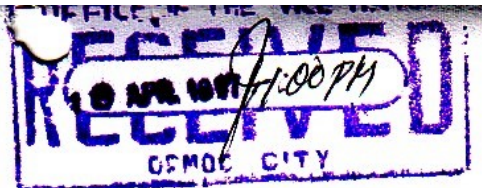
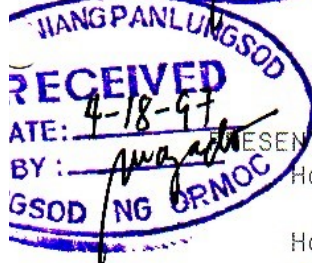

RESOLUTION NO. 97-64

A RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE CITY
MAYOR EUEROCINO M. CODILLA, SR. TO KINDLY CAUSE THE
INDICATION IN ALL CONTRACTS THE NUMBER OF THE
SANGGUNIANG PANLUNGSOD RESOLUTION WHICH AUTHORIZED HIM
TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF
ORMOC, SUCH CONTRACTS, AND TO FURNISH THE SANGGUNIAN
COPIES THEREOF FOR ITS INFORMATION AND RECORD PURPOSES.

WHEREAS, Section 22, par. (c) of Republic Act 7160, otherwise known
as the Local Government Code of 1991, provides:

"Unless otherwise provided in this Code, no contract
may be entered into by the local chief executive in behalf
of the local government unit without prior authorization by
the sanggunian concerned. A legible copy of such contract
shall be posted at a conspicuous place in the provincial
capitol or the city, municipal or barangay hall."

WHEREAS, it has been observed and noted that contracts signed by
the Honorable City Mayor for and in behalf of the City Government of
Ormoc pursuant to a Sangguniang Panlungsod Resolution authorizing him to
sign such contracts do not bear the Sangguniang Panlungsod Resolution
number which, though not essential for its validity, but certainly will
immediately give color to its validity, hence, should be encouraged and
practiced;

WHEREAS, for information and recording purposes, it is the desire of this Sanggunian that it be furnished copies of contracts referred to in the next preceding paragraph.

WHEREFORE, foregoing premises considered, on motion duly presented by Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, seconded by Kagawad Benjamin B. Lladoc; be it


