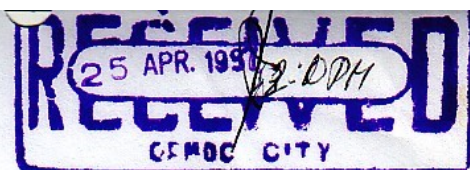


ENACTED, April 24, 1997.
